

# Citizens' Survey

On Monday, October 2, the Area Council held its regular monthly meeting. Topics discussed were: Fire District 43; Citizens' Survey; and Rural Economic Opportunities.

### **Councilman Dunn**

King County Councilman Reagan Dunn visited the Area Council. He made some opening remarks regarding on-site sewer systems, garbage collection, exempt private wells, taxes, and transportation infrastructure. He took a series of questions from members of the Public and the Area Council.

### **Fire District 43**

Aaron Tyerman, Chief of Fire District 43, discussed the ramifications of the recently failed August ballot measure. Serious budget issues remain. The Maple Valley Fire Station 83 (on 216th Ave SE near the PlaMor Tavern) was recently closed due to budget cuts.

Chief Tyerman stated his staffing is now down to seven firefighters (similar to 1993 levels!) with a total staff is 52. He stated 91% of his budget goes to wages and benefits. The average age of firefighters of 47 yrs old also is of concern.

The district is getting some support from other nearby districts (which is reciprocated), but this is not sustainable, since they can't staff such help indefinitely.

Chief Tyerman plans to continue support 911 service and other critical services as priorities.

On this November's ballot there will be a Levy Lift. It would take the \$1.16 per \$1,000 assessed value back to \$1.50. Should the Levy Lift not pass, Chief Tyerman stated he will have to layoff ~20% of staff in the next year.

## Citizens' Survey

The Area Council is finalizing the questions for its Biennial Citizens' Survey. The Survey has proved one of the best ways to ascertain concerns, issues, etc. of citizens' in our Rural Area. The Area Council uses results of these Surveys to better engage officials of King County and other government agencies on issues of importance to Rural Area citizens.

Rural Area citizens will receive a postcard in the mail announcing when they can go online on the Area Council's web site to take the Survey. Please watch for it. Thank you in advance for participating in helping keep our government officials cognizant of issues facing the Rural Area.

# **Rural Economic Opportunities**

The Puget Sound Regional Council's (PSRC's) Economic Development Board approved a Regional Economic Strategies (RES) plan. The Area Council provided detailed comments earlier this year (see the Area Council web site's *Correspondence* page) on the rural aspects with many being accepted. The Area Council plans to work with PSRC Staff who are tasked with both finalizing and implementing the plan.

The Area Council is hosting an all-Rural Area UAC meeting on Tuesday, November 28, from 6:30 - 8:30 PM, at the KCLS Service Center, 960 Newport Way, Issaquah with PSRC and King County officials to discuss the RES and its implementation.
