MAPLE VALLEY AREA COUNCIL

SECRETARY OF STATE STATE OF WASHINGTON

The undersigned, Al Kofal, Bill Ziegner, and Mike Reichert for the purpose of forming a corporation under the non profit laws, RCW24.03 of the State of Washington, state:

Ι

The name of the corporation shall be " Maple Valley Area Council ".

II

The term of existence shall be perpetual.

III

The purposes for which the corporation is organized are as follows:

- 1.) To contribute to the growth and orderly development of the community area generally defined as the area encompassed by the Tahoma School District No. 409.
- To make and publish studies which promote and improve the community.
- 3.) To act as a liaison for the community in providing area representation, sentiment and expression to the county, state and federal agencies of government; and
- 4.) To have and exercise all statutory powers necessary or convenient to effect any or all of the purposes for which this corporation is organized.
