Subjects: <u>HB 2206</u> and <u>HB 2536</u>

House Environment and Energy Committee Members,

Our Unincorporated Area Councils (UACs) and Unincorporated Area Associations (UAAs) collectively constitute nearly all of the King County unincorporated Rural Area from the Snohomish County line to the Pierce County line. We have studied each of the subject proposed bills and we urge you to reject each:

<u>HB 2206</u> would allow Urban services *outside* of Urban Growth Area (UGA) making urbanization of the Rural Area easier and, possibly, more likely, something all our Unincorporated Area Councils and Associations have been against for many years.

<u>HB 2536</u> would amend the State's Growth Management Act (GMA) to promote urban growth in the Rural Area, something that also all our Unincorporated Area Councils and Associations have been against for many years.

Each of the subject proposed Bills appear to directly conflict with one of the basic premises of the King Countywide Planning Policies (CPPs) and the King County Comprehensive Plan (KCCP)--keeping the Rural Area rural and protecting the integrity of the Urban Growth Boundary--the key foundations of the GMA.

Please reject each of the subject proposed Bills.
