1. TSD Update-- Val Paganelli (TSD Board Member) (7:05):
 - Superintendent Mike Hanson will be at the November GMVUAC meeting.
 - Originally 100% remote learning through 1st quarter, however K-2nd grade may start sooner (10/19/2020) but this might also be slowed down if Covid-19 cases continue to increase.
 - Families can select a preference of remote learning, in class learning, or staying with a specific teacher for whatever that teacher is doing.
 - If Covid-19 cases stay under 75 per 100,000 more kids could be moved to in classroom starting with younger kids.
 - There is a TSD board meeting scheduled October 13, 2020.
 - There have been a number of students who have switched to homeschool, other online schools, or Running Start. Some Students may not be participating at all.
 - TSD is still trying to figure out how to measure participation and the effectiveness of remote learning.
