- 1. TSD Update-- Val Paganelli (TSD Board Member) (7:04):
- TSD will start at the same time as usual.
- K-12 will be 100% remote for the first quarter.
- May have partial in class learning if the is support from the Department of Health.
- District has not had to prepare online learning before, currently taking input from community, students and parents.
- Have issued laptops/ hotspots for students w/o computers/ internet.
- State may not provide funding for busses if there is no in class learning.
- There was a motion to rebate tax payers for services not rendered/ roll back 2021 local levy by 50 cents per \$1000—Motion was not supported. May be re-discussed in October.
- \$37 million is the general surplus fund.
- Looking into testing/ attendance to determine is online learning is working, how to identify success.

- Rimbos
- Two sets of comments were approved by the Executive Committee and submitted to the KCC on July 13, 2020 and July 23, 2020.

- Executive Committee had to approve comment letters due to the problems with KCC process.
- The whole GMVUAC has to approve these actions.
- Motion: Hansen- Move to approve the two sets of comments sent out to the King County Council that were approved by the Executive Committee. Second: Haynes, Approved – Unanimous.
- 2. Material Processing:
- Rimbos:
- Proposed we review code related to Material Processing to prevent more Industrial Sites.
- 3. Open Discussion:
- Harvey: Ravensdale Intersection.
- 20 Acres- property owner is wanting to divide into 5 acre lots.
- Mike Birdsall provided comments due to permitting by Friday.
 - 21-acre parcel currently RA-10, property owner is requesting it be re-zoned to RA-5 and turn it into 4 lots.
 - o First problem- would create precedent to up-zone other 10to 20-acre lots to RA-5.
 - Second problem- has to do with Counties Transfer of Development Rights (TDR), does it comply with previous contracts.
 - In 1997 there were 14 separate parcels with 349 acres zoned RA-10
 - In 1998 Boundary Line Adjustment created 13 parcels just north of these 21 acres.
 - Second Boundary Line Adjustment in 1999 created 9 different 5-acre lotas (even though zones RA-10)
 - This left 4 additional lots including these 21 acres.
 - There should have been 34 development rights from the 340 acres, possibly sold some development rights already.
 - Should only have 1 development right left for the last 3 parcels.
- Growth Management Committee needs to get more information.
- 4. Queen City Farms
- Trump Administration wants to remove sites from Superfund priority list.
- On July 14 the US Environmental protection Agency (EPA) published a Notice of Intent to Delete the Queen City Farms Superfund Site.
- A 30-day comment period runs through August 13, 2020.
- GMVUAC does not want this site to be delisted.
- Environment Committee will conduct research on the site and put out a draft comment letter in the next couple of days.
- GMVUAC will need to approve comment letter before it can be submitted by August 13, 2020 deadline.
- Motion: Rimbos- Motion to have a special meeting August 10, 2020 to discuss QCF comment letter. Second: Haynes, Approved Unanimous.
