- 2. TSD Update-- Val Paganelli (TSD Board Member) (7:08):
- Busy time of year- end of School.
- Graduations this week (Friday), will be on campus again this year.
- Parade: Students will decorate their cars and follow an undecided route.
- Had to approve Covid-19 Recovery Plan/ Process by June 1, 2021- can be seen on website through June 21, 2021.
- This is an election year for two seats- Val and district 2 (Katrina Montgomery)
- Val is running for re-election.
- Board President Katrina Montgomery is moving out of state and is resigning, will need to be replaced. Vice President will step in for now.
- Q. Will there be make up summer school?
- A. Yes, part of Recovery Plan- not mandatory- but recommended for those who need it, it will be July- August.
- Q. How many students will graduate?
- Will have to get back to you on that with a number, last few years have been about 600.

- 3. Proposed Roads Levy Lify- John Taylor (DLS- Director) (7:17):
- John Taylor discussed the Proposed Roads Levy Lift.
- County Council is contemplating a Roads Levy Lid Lift.
- County has road tax, property tax (which increases 1% per year (plus inflation)) and a gas tax.
- Lots of systems, 1500 miles of roads to maintain.
- Needs voter approved levy to max \$2.25 per \$1,000 assessed value. (A 22% increase)
- Current Levy is 1.83, new levy would hold it at 2.25 for 6 years, then it would return to current rate.
- Would add a road crew, will add to operating budget.
- Would add capacity to get more grants and to match some grants.
- Trying to got onto November 2, 2021 ballot.
- Reagan Dunn is supportive, as or lots of other council members.
- Q. What would it be spent on?
- A. Staffing first, roadway resurfacing, to make intersections, crosswalks, and sidewalks safer and lot of culverts need worked on. It buys time to figure out regional funding.
- Q. Who would vote/ pay for this tax?
- A. Would only apply to unincorporated residents.

- Homepage has a lot that needs done.
