- 2. King County Budget Dwight Dively (PSB Director) (7:10):
- Quick overview of the budget:
 - o 60+ services.
 - o 16,700 employees.
 - o 15.8 billion
- Bi-annual budget, currently working on the 2023-2024 budget.
- 140 different funds, each with its own restriction.
- The general fund is the only flexible source of money, around 15% of the budget.
- Largest budget- charges for services.
- Taxes are 28% of the budget.
- Also get grants/ debt etc.
- Metro is the largest budget around 20% of the total.
- Waste water
- Community and human service growing cost.

- Criminal justice.
- 45 million in bonds for affordable housing.
- 28.5 million for fish culverts.
- 180 million for fully electric bus line.
- 43 million to build zero emission facilities.
- 2.1 million co- responder service.
- 9 million for reducing gun violence.
- Additional roads staffing.
- American Rescue Plan around 2 billion for covid assistance- some of this has yet to be spent.
- General fund revenues around 2.2 billion for next 2 years.
 - Only 1.3 billion if you remove what other governments pay us for services such as sheriff.
- 57% is property tax.
- General fund appropriations:
 - o 21% is sheriff.
 - 75% goes to criminal legal administration.
