- Been working on this for three years, ends in December 2024.
- Have given oral testimony to the Local Services and Land Use every meeting since January 17, 2024.
- Last meeting was April 17, 2024, this is the last time oral testimony was taken.
- Cancelled the May 1, 2024 meeting.
- May 15, 2024 is next meeting.
- May 14, 2024 is when the Striker comes out.
- Over the last few weeks, they have been working on the striker.
- Document is over 1,000 pages.
- On June 5, 2024 they will vote on the recommendations.
- That vote will send it to the full KCC.
